

- Illegal Controlled Substances are not permitted on Club Premises. This type of behavior is not tolerated. Any person caught doing illegal behavior will result in the loss of a Club Privileges.
- Loud and excessive noise or profane language will not be tolerated.
- Business meetings are not permitted at the bar.
- Club membership cards must be shown to receive your first drink.
- New Members may enter the Association on a receipt until their Membership is issued. They must be signed in by an active Member and are not permitted to make purchases of any kind until receiving a Membership Card.
- If a Member sponsors a Guest, the Member must stay with that Guest. When the Member vacates the premises, the Guest must also leave. The Guest is permitted to be signed in only one (1) time per day. The Guest may not come back into the establishment with another sponsor on that same day.
- Guests cannot purchase alcoholic beverages while visiting the establishment, the member who signed the guest in or another member must make the purchase for the guest(s).
- Guests may play small games of chance and other club raffles with the exception of the daily book.
- A guest may only be signed in 3 times before he or she must join the club.
- Members that are on probation (for the first 2 years) may only sign in one member.
- Active members may sign in up to three guests at a time.
- Members who fail to renew their annual dues by 12/31 but renew before 01/31
 of the next year, will have to pay \$75 to rejoin. The application must go through a
 floor meeting, and they must attend new member orientation. They will not lose
 their years and status as an active member once they receive the membership
 card after completing the orientation.

- Members who fail to rejoin prior to 01/31 of the next year must pay \$75 to rejoin.
 The new application must go through a floor meeting, and they must attend a new member orientation before they receive their card. However, they will lose all prior active status as a Member.
- New members are on probation for 2 years. They are encouraged to attend floor meetings but cannot vote until they become a full active member after 2 years. (The start of their 3rd Year as a member)
- Members may not sponsor a new member until they become an active member after 2 years.
- When the kitchen is open, there will be no smoking inside the Club premises anywhere.
- When club activities are taking place in the back room, there will be no smoking in this area. Smoking however will be permitted in the bar area.
- There may be some other club activities which cause the entire club to be nonsmoking, i.e. BB team practice, Hunters Safety Course etc.
- No outside beverages may be brought into the club house.
- The club is cash only establishment, no credit cards accepted. There is an ATM in the club for members to utilize.
- A check may be used to pay for club dues only.
- No person under the age of twenty-one (21) is permitted to participate in Small Games of Chance.
- No person under the age of twenty-one (21) is permitted to be seated at the bar at any time.
- All persons under the age of **twenty-one (21)** must be accompanied by a parent or legal guardian at all times while in the bar area.
- Children under the age of twelve (12) are not permitted to shoot darts or play pool.
- All persons under the age of eighteen (18) must vacate the premises by 10:00 PM.
 When a club function is scheduled, premises must be vacated by 9:00 PM. This includes age's eighteen (18) through twenty (20). You must be twenty-one (21) years of age to stay for a club function. (Times may vary, if so it will be posted)
- All beverage pitchers must be served at tables; pitchers are not permitted at the bar.
- Bartenders are not permitted to loan money to any person while on duty.

- Bartenders are not permitted to play Small Games of Chance games if they sold tickets out of a game. If they did not sell tickets out of a game they are permitted to purchase tickets out of that game.
- Bartenders are the only persons permitted to open the main entrance door when
 the bell rings. If a Member does not have a membership card in their possession
 they must sign the register book. If this practice is repeated three (3) times, that
 person will not be permitted inside the club until the membership card is visible
 to the bartender.
- Over pouring of alcohol is prohibited.
- Serving alcohol to visibly intoxicated persons is not permitted.
- Bartenders are not permitted to drink any alcoholic beverages before their shift
- PLCB rules state one (1) FREE drink per patron per day is permitted
- Small Games of Chance tickets are not permitted to be held. Tickets must be cashed in. No tickets can be removed from the club.
- No Member is permitted to buy out a Small Games of Chance ticket bowl
- All Small Games of Chance bowls are open bowls. All patrons shall have common courtesy to every person playing these games. All patrons are permitted to play any game at any time during regular business hours.
- No free jar bowl tickets will be given away. (Exception; if there is a faulty bowl. Ex

 If there are three (3) tickets to a bundle and only two (2) were included in the bundle).
